INDEPENDENT PRACTITIONER'S ASSURANCE REPORT TO THE DIRECTORS OF HONG KONG BLOOD CANCER FOUNDATION (the "Permittee") FOR THE GENERAL CHARITABLE FUND-RAISING ACTIVITY HELD DURING THE PERIOD FROM 25 NOVEMBER 2015 TO 3 JANUARY 2016 Public Subscription Permit No. 2015/291/1

Pursuant to the conditions stated in the Public Subscription Permit issued by the Social Welfare Department of the Government of the Hong Kong Special Administrative Region ("SWD"), we have been requested to report on the attached income and expenditure account of the Permittee's general charitable fund-raising activity held during the period from 25 November 2015 to 3 January 2016 ("the Event").

Responsibilities of the Directors

Practitioner's Responsibilities (continued)

The work undertaken in connection with this engagement is less in scope than an audit conducted in accordance with Hong Kong Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters and other procedures we considered necessary. The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

Inherent Limitations

Due to the nature of cash receipts and expenses relating to the Event, it was not practicable for us to determine whether the income and expenditure account and the books and records of the Permittee include all transactions relating to the Event. It was impracticable for us to quantify the potential impact of this on the income and expenditure account. Accordingly, our report relates solely to the income and expenditure account prepared from transactions that have been recorded in the Permittee's books and records.

Conclusion

Based on the foregoing, we report that nothing has come to our attention that causes us to believe that the attached income and expenditure account does not reflect, in all material respects, the gross subscriptions raised and the expenses incurred by the Permittee in respect of the Event that have been recorded in its books and records made available to us in accordance with the basis of preparation set out in note 2.

Intended Users and Purpose

This report is intended solely for the purpose of assisting the Permittee to satisfy the conditions stated in the Public Subscription Permit issued by SWD in connection with the Event and is not intended to be, and should not be, used for any other purpose. We agree that a copy of this report may be provided to the Director of Social Welfare without further comment from us.

NOTES TO INCOME AND EXPENDITURE ACCOUNT FOR THE GENERAL CHARITABLE FUND-RAISING ACTIVITY HELD DURING THE PERIOD FROM 25 NOVEMBER TO 3 JANUARY 2016 (PUBLIC SUBSCRIPTION PERMITS NO. 2015/291/1)

1. GENERAL

The general charitable fund-raising activity held during the period from 25 November 2015 to 3 January 2016" is an event organized by Hong Kong Blood Cancer Foundation ("the Foundation") for the purpose to raise funds for helping blood cancer patients and related medical research.

2. PRINCIPAL ACCOUNTING POLICIES

Basis of account

The income and expenditure account has been prepared using the historical cost basis of accounting.

Income recognition

Donation income is recognized on a cash basis.

3. TAXATION

As the Foundation is registered as a charitable organization under Section 88 of Inland Revenue Ordinance, the Event is exempted from Hong Kong profits tax.
